Detailed below the last injuries and fatalities following the Covid-19 injections in the UK – data released by the MHRA December 28, 2021.

### UK – HARM TO CHILDREN – COVID-19 INJECTIONS

The MHRA is now reporting in its weekly update report on the number of children being injured by the Covid-19 injections. All 3 of the UK injection brands have now been administered to children. It is not clear if these cases of harm are included in the overall adverse events and deaths reported for the UK by the MHRA. We have raised an FOI request to establish the correct position.

In their latest write up the MHRA report that to the 8th December 2,344 reports have been raised about harm to children, no information has been given as to whether any of these reports also include cases where a child has died following a Covid-19 injection.

"The experience reported in under 18s is similar to that identified in the general population and a review of these reports does not raise any additional safety topics specific to this age group"

Latest UK Adverse Reactions and Fatalities to 8th December 2021, per the MHRA, following the experimental Covid-19 injections (released by the MHRA on 16th December 2021).

A total of 1,852 deaths now reported by the MHRA along with over 1.3 million injuries suffered by almost 405,000 people (an average of 3.3 injuries per person) following the experimental Covid-19 injections

Note: The number of injuries /deaths reported are dependent on many factors including numbers of injections administered, how many of these have been second and now third doses along with the age groups of those who have received those doses and indeed the work of the MHRA in ensuring all cases by all manufacturers get investigated and reported in a timely and consistent manner. In addition, with booster / third doses the govt is also now mixing and matching injection brands and it is not clear how adverse events are being recorded against a particular manufacturer. On average 722 people per day in the UK has reported an adverse reaction. Each report on average contains details of over three injuries suffered.

30 additional deaths following the injections have been reported in the last 7 days, on average more than 4 per day.

### UK

In the last 7 days only:

There were 5,052 extra individual reports of adverse reactions following the Covid-19 injections in the last week amounting to 16,811 extra reported injuries/ deaths. In addition, there were 30 extra deaths reported in the latest report from the MHRA.

16 of these additional deaths in the last 7 days were reported as being from Pfizer, with 11 additional deaths in the last week being reported from AstraZeneca and 3 where the injection manufacturer was unknown.

Per the MHRA over 47% of people in the UK with a second dose have now had a booster injection. Take up is much lower on average in Northern Ireland and higher than average in Scotland.

The MHRA is now reporting in its weekly update report on the number of people being injured by the "Booster" Covid-19 injections.

It is not clear if these cases of harm are included in the overall adverse events and deaths reported for the UK by the MHRA. We have raised an FOI request to establish the correct position.

In their latest write up the MHRA report that to the 8th December 18,554 reports have been raised about injury following "booster" injections, no information is given as to whether any of these reports also include cases where the person has died following the Covid-19 injections.

77% (last week 76%) of the population (adults and children) have received a first dose of a Covid-19 injection and 70% (last week 70%) have received a second dose.

Over 4.5 million people have received a first dose but have not yet received a second dose.

A total of 1,852 deaths now reported by the MHRA along with over 1.3 million injuries suffered by almost 405,000 people (an average of 3.3 injuries per person) following the experimental Covid-19 injections

Table shows the percentage of people (adults and children) with either no dose or no second dose of a Covid-19 injection in each of the four nations

30% of the UK population (adults and children) has either not received any dose or no second dose of a Covid-19 injection.

Over 4.5 million people have received a first dose but have not yet received a second dose and over 15.6 million have received no dose at all. MHRA suggests 163,172 doses were administered to those with no previous dose and only 45,403 doses to those who had not yet had their second dose.
